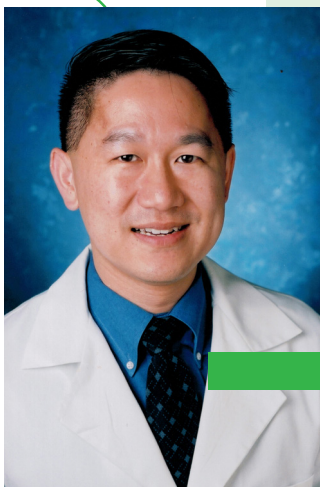
DR. LIN'S JOURNEY TO SOLO PRACTICE SUCCESS
